

# Regulation of #T-TeC 2025

## (Telespazio Technology Contest - 7<sup>th</sup> edition)

### INTRODUCTION

---

#T-TeC (Telespazio Technology Contest) is an initiative promoted by **Telespazio<sup>1</sup>** and **Leonardo** to enhance university research activities in a “*Open Innovation*” environment. This contest is part of the “*Solvers Wanted*” of Leonardo and it addresses all students, PhD students and researchers from university departments of all Countries who are willing to collaborate and test their ideas with Telespazio and Leonardo on innovative technological themes in the Space sector.

The contest supports multidisciplinary ideas, proposals and projects concerning technological themes of strategic importance to space domain.

#T-TeC is a unique opportunity to present some of proponents’ cutting-edge research and ideas to Telespazio and Leonardo innovation managers, contributing to enhance their high scientific-technological content. It is also an opportunity for students, graduates and non-graduates, to acquire professional growth and visibility for future collaborations.

### HOW TO PARTICIPATE

---

The #T-TeC 2025 is open to STEM (Science, Technology, Engineering, and Mathematics) people, such as

- Students/ PhD’s (graduated and non-graduated)
- Researchers (research fellows are also allowed to participate)

from all Universities in the World.

It will be possible to participate individually or in groups (max 5 people) or through team composed by researchers belonging to departments of different universities and Countries and with different skills.

The Proposal template can be downloaded from the Telespazio website at the [#T-TeC 2025 home page](#) and from Solvers Wanted web page ([solverswanted.leonardo.com](http://solverswanted.leonardo.com)). The **Proposal** (in Adobe® PDF format) and a **Presentation** (in Microsoft® PowerPoint format) shall be provided in English.

In the Proposal, the candidates must briefly describe the project, highlighting its strengths and innovation. For what concerns the Presentation, it must contain a **maximum of 10 slides**. In the Presentation, the candidates must describe the project in detail, the evidence of potential impact/innovation of their idea /solution, making also use of pictures and graphics to better explain the proposal content. Candidates are free to use their preferred template for the Presentation.

**The deadline for submitting the Proposal, the relevant Presentation and this Regulation signed by all team members is February 20th, 2026, 23:59 CET**. They must be sent to the e-mail address [proposals.ttec@telespazio.com](mailto:proposals.ttec@telespazio.com).

## TECHNOLOGICAL THEMES AND CATEGORIES

---

There are two different types of categories:

❖ According to **the TRL Technology Readiness Level (TRL)<sup>2</sup>** of the proposed innovation:

- **Idea**, for TRLs lower than 4;
- **Prototype**, for TRLs 4 or above.

❖ According to the **type of Innovation**:

- Mission Concept
- New Technology

Each proposal shall fall into the aforementioned categories spanning through the following Technological Themes:

- **Space Exploration, Extra-terrestrial Exploitation & In Orbit Servicing** (Systems - including Space Robotics-, Services)
  - Sustainable and innovative technologies and solutions for new space services to support the operations of Scientific/Commercial Space Exploration and related logistics for orbiting platforms and human space flights and operations (e.g. Commercial Low Earth Orbit

Platforms, Lunar Gateways, habitats, rovers, landing/ascending vehicles, cis-lunar transport vehicles)

- Innovative solutions, hardware and software, for enabling In Orbit Services, ranging from deorbiting and satellite life extension to the in-orbit replacement of damaged subsystems, capable to support the role of an In-Orbit Service Provider and End-to-End Large Mission Integrator, as well as In Orbit Operations Responsible
- **Space Domain Awareness for the Protection of Space and Ground Infrastructures** (Data, Algorithms, Services, Hardware)
  - Innovative value-added services and solutions based on Service and Data Provision Platforms to provide data and solutions related to space situational awareness, including space weather, space traffic management, and space intelligence. Solution could be both space and ground based.
- **Positioning, Navigation and Timing (PNT) Solutions for Earth and other celestial bodies** (Systems, Algorithms, Services) **and Emerging Space-based Connectivity Solutions** (Technology, Services)
  - Technologies and solutions to drive innovation in the field of PNT-enabling or PNT-enabled services, where their applications can be on the Earth, on the Moon or in the Space at large, including the exploitation of the concept of “Navigation-as-a-Service” and related infrastructures to seamlessly provide services also in case of denied Satellite-based (GNSS) Navigation.
  - New concepts, systems, and services exploiting emerging technologies such as Optical, Quantum, and Direct-to-Device for Space-to-Earth (and vice versa), Space-to-Space, Space-to-Moon (and v.v.) and Earth-to-Moon (and v.v.) secure and reliable communications

## **SUBMISSION CRITERIA AND RULES**

---

In each proposal shall be indicated: Technological Theme, TRL and Category types.

Universities will have the opportunity to present one or more projects (each project must have a different team leader) each applying to one or more of the above Themes (cross-Themes projects are welcome) and to only one Category. In case of cross-Themes projects, the main Theme shall be identified.

It is **not** allowed to submit projects already presented in the #T-TeC past editions or related to initiatives/studies that are part of collaborations/contracts already in place with Telespazio Group or Leonardo.

The proposed innovation may concern:

- ❖ Enabling software technologies which can be integrated at a higher level, and which allow their use in different solutions, environments and scenarios;
- ❖ Implementation of physical/mathematical models in tools and algorithms for modelling and simulation of complex operating scenarios;
- ❖ high-level architecture view, performance and interfaces among the various system components;
- ❖ innovative services based on traditional or innovative architectures and systems

also providing an analysis of economic-technological feasibility together with the related usage scenarios.

## **EVALUATION CRITERIA**

---

The presented proposals will be evaluated based on the criteria presented in the following tables; for each evaluation criterion a score of 1 to 5 points will be assigned and different weights are associated.

<b>Technical and scientific content of the idea / innovation, including the possibility to apply the proposed solution in non-space application areas</b>	15%

Telespazio and Leonardo will have the right to invite other members, always with an outstanding position and knowledge of the Space domain, to the evaluation committee belonging to other institutions and companies.

## PROCESS AND AWARDS

---

#T-TeC 2025 is launched on December 12<sup>th</sup>, 2025, during [NSE – New Space Economy Expoforum](#) in Rome and will be closed on February 20<sup>th</sup>, 2026.

During this period, the Organizing Committee will be available to answer questions from potential candidates: questions can be sent to the e-mail address [proposals.ttec@telespazio.com](mailto:proposals.ttec@telespazio.com). All questions and their answers will also be published on Telespazio website at the [#T-TeC 2025 home page](#).

The week after the deadline (**February 23<sup>th</sup> - 28<sup>th</sup>, 2026**) will be dedicated to a preliminary screening to short-list received proposals and to select those that will participate to the Pitch Contest<sup>3</sup>: Team Leaders of short-listed proposals will receive communication via e-mail in due time.

During the week of **March 2<sup>nd</sup> – 6<sup>th</sup>, 2026**, the short-listed proposals will be presented (from remote, using web conferencing tools) to the Evaluation Committee during the Pitch Contest. The Evaluation Committee will evaluate the proposals presented in accordance with the above-mentioned evaluation parameters. The Evaluation Committee will select the Winners and reserves the right to also identify proposals deserving Special Mentions.

On **April (date to be confirmed)**, there will be the Awards Ceremony where Winners and Special Mentions will be unveiled. The Winners will be invited to participate in person and Telespazio will pay for travel, hotel accommodation for one representative for each of the winning teams. Travel and official ceremony details will be explained to Winners at due time. To allow travel organization, the Winners will be contacted in advance: for these reasons, ***the Winners and in general all the candidates are bound by confidentiality obligation on the contest outcome until the results will be published by Telespazio and Leonardo.***

There will be Winners for the four Categories:

❖ Idea Category:

- One award, the amount will be € 5,000 (before taxes), to be divided in equal parts among the members if the proposal is presented in a team

❖ Prototype Category:

- For the First Place award, the amount will be € 10,000 (before taxes), to be divided in equal parts among the members if the proposal is presented in a team
- For the Second Place award, the amount will be € 6,000 (before taxes), to be divided in equal parts among the members if the proposal is presented in a team
- For the Third Place award, the amount will be € 4,000 (before taxes), to be divided in equal parts among the members if the proposal is presented in a team

In case there will be an ex-aequo, the prize will be divided in equal parts among the ex-aequo winning teams and in turn for each team, in equal parts among their members.

The Special Mentions will receive a Certificate.

To foster the possibility to establish collaboration for future businesses, Telespazio and Leonardo will offer to #T-TeC 2025 participants the following opportunities, which will be decided at the discretion of the commission, considering the type and readiness of the projects presented.

- One or more position to enter a Pre-incubation phase into the Space Business Catalyst powered by Thales Alenia Space for 3 months.
- One or more position in the Pre-incubation paths with *ESA BIC Turin* for 6 months
- One or more position in the ESA BIC Brindisi pre-incubation programme for a duration of 4 months
- One or more positions in “Supporting Services” to apply to *ESA BIC Lazio* and /or Technology Transfer Lazio for 4 months

A research contract to support 6-months Proof of Concept (PoC) of the proposed idea which is worth up to € 20,000, with no obligation to establish a startup company.

Telespazio and Leonardo reserve the right to unilaterally increase the number of proposals that will be supported with the research contract for the PoC.

Telespazio, as organiser of #T-TeC 2025, guarantees that it shall have no rights over the Background Intellectual Property Rights contained in the Proposals, the Presentations or the Demonstrations. Nothing in the contest shall affect the ownership of the Background Intellectual Property Rights or imply any licence to a party's Background Intellectual Property Rights unless granted expressly.

In case of further collaboration, the management of the Intellectual Property Rights will be defined and agreed case by case

## CONFIDENTIALITY AND DATA PROTECTION

Telespazio, as organiser of #T-TeC 2025, will ensure the confidentiality of all the submitted Proposals and related materials. The submitted Proposals, as well as the stored status of the submission, will be protected against unauthorised access by third parties. Subject to the signature of the Release Statement in Annex 2, participants' personal data will be processed according to the Privacy Policy attached in Annex 3 subject to participant acknowledgment and signature.

During the Awards Ceremony, the awarded Proposals will also be made public along with the Winners.

Policy pursuant to Article 13 of Regulation (EU) 679/2016 ss.mm.ii. (the "**GDPR**"), and of the Italian laws that integrate it as amended. ("**Applicable Privacy Law**") (the "**Policy**") - Processing of personal data.

Pursuant to Article 13 of the GDPR, Telespazio S.p.A. ("**Telespazio**") provides this Policy regarding the processing of personal data provided by participants in training, professional updating, promotional and any other type of events organized by Telespazio ("**Event**").

### 1) DATA CONTROLLER AND DATA PROCESSORS FOR THE PROCESSING

### 2) DATA SUBJECTS AND CATEGORIES OF PERSONAL DATA

- d) exercise the right to portability, within the limits set out in Article 20 of the GDPR;
  - e) withdraw the consent at any time, without prejudice to the lawfulness of the processing based on the consent given before the revocation;
  - f) file a complaint with the Personal Data Protection Authority, following the procedures and instructions published on its official website ([www.garanteprivacy.it](http://www.garanteprivacy.it)).
